Proposed Bylaws and Handbook Changes

Bylaws committee recommends the two changes (indicated by *) to the Bylaws and three changes (indicated by * and italics) to Handbook:

ARTICLE III - MEMBERSHIP

Section 2a:

- *Suggested change 1: elected changed to selected in Section 2a to read:
- **a.** Active membership shall include charter members and those subsequently *selected* to active membership. **Section 3:**
- a. Active Membership:
- *Suggested change 2: in Section 3a.2. elect changed to "act to approve".

Section 3: a.2. to read: The Board of Directors shall *act to approve* new members from candidates recommended by the Membership Committee.

- *2.e. <u>selection motion result</u> change to: *individuals selected for membership* To read:

2. Selection of Candidates

- d. Points shall be assigned each nominee by the five members of the Membership Committee. The Chair shall tabulate the results and prepare a membership selection *report for Board approval*. (1989, 2005, 2015, 2016)
- e. A listing of all nominees, state, nominators, point tally, and *individuals selected for membership* shall be sent to the Executive Secretary for permanent filing. (1969, 2016)
