### *Pre-Dinner Minutes*

The meeting was called to order by President Suzanne Butch.

**Treasurer's Report:** the financial statement of AMTF as published in the Spring 2009 newsletter showed the balance in parentheses, indicating the balance was a negative when it was not; when the CDs come due, the market will be assessed for reinvestment for a higher yield; certified letters are sent to non-dues paying members after the second e-mail notice. 33% of members were late with dues, this is costly to the fraternity. **Audit:** no irregularities were noted; the audit balanced to the penny. **Bylaws:** Copies of proposed changes were published in the newsletter; the Handbook has been updated, pending general member-

ship approval. **Finance:** proposed Budget to be available at the Post-Dinner meeting.

**Membership:** Applications were processed by e-mail; all nominees were accepted: Jean Bauer, Norma Bivona, Karen Brown, Karen Coppens, Elizabeth Leibach, Judy Parsons, Halcyon St. Hill, Ginger Weeden. **Nominations:** Candidates for office are: Vicki Freeman, President-Elect; Debbie Faubion, Secretary; George Fritsma, Junior Board Member. **Social:** buses at 6 PM for US Cellular Stadium Club, information posted on ASCLS bulletin board. Items for auction include 5 pearl necklaces, a pin, wine stopper, vodka, wine and Chicago "stuff". **Scholarship:** Duncan Samo was reappointed to a 2 year term; one student who received an E & R scholarship withdrew from school. The award was not given to the next qualified

recipient; Committee would like clarification on how to award points when deciding need. No provision exists that disallows someone from getting more than one scholarship in successive years. **Newsletter:** written report submitted. **Officer Reports:** President Butch recommended all forms be available via e-mail & suggested AMTF have a webpage which would have application forms, be free standing and linked to ASCLS's webpage. Motion passed. **Jr & Sr Board members:** it was confirmed the AMTF President notifies all scholarship winners, including E & R Fund; Myra Myers would like to see a template for a Press Release in the Handbook. **Executive Secretary:** unable to attend. To comply with IRS regs, the Exec Secretary will send original income documents to the treasurer. Meeting adjourned. *Continued p.3*
